Narrative text

At approximately 1410 hours, on 09/23/11, the undersigned was patrolling the area of the PEIF Building, in an attempt to locate MALEPORT's stolen bicycle, reported earlier this date. As the undersigned was traveling through Parking Lot #60, a male subject was observed riding a bicycle near the driveway to the PEIF loading dock. The subject was traveling eastbound, toward the Berry Event Center. The undersigned noticed that the bicycle was a girls bike, a Roadmaster Mt. Fury, 15 speed, silver & blue in color, and extremely undersized for the male subject riding it. The undersigned observed the rear tire was going flat/low from the subjects weight and his knees were coming close to hitting the handlebars.

Given the numerous bike larceny reports this department receives, the undersigned decided to make contact with the male subject and ask if he owns the bike he's riding. The undersigned made contact and explained the observations made. The undersigned asked the subject if the bike belongs to him. The subject stated that the mountain bicycle, in fact, is not his, however he borrowed it from his roommate. The subject identified himself as AYNSLEY and stated he is on the "varsity" team. The undersigned was not familiar with that term for college sports, so asked him what sport he plays. AYNSLEY said he is a hockey player and is on his a way to the Berry Event Center, now, for a team practice.

The undersigned explained to AYNSLEY that she has no information, at this point in time, if the bike he is riding is stolen or not, but he just looked really strange/suspicious riding such an undersized "little girls" bike. AYNSLEY commented that "our bikes get taken all the time". The undersigned asked AYNSLEY to clarify whose bikes get taken? AYNSLEY said his friend's, on NMU Hockey Team, bikes. The undersigned asked if they have reported their bicycles as stolen with Public Safety. According to AYNSLEY, it's no big deal, as the bikes are shared amongst team members and normally come back.

Since the undersigned had no further information regarding the bicycle AYNSLEY was riding, coupled with the fact that his name and athietic team are known, the undersigned allowed AYNSLEY to continue on his way to practice. The undersigned also continued to look for MALEPORT's stolen mountain bike. The undersigned continued to watch, as AYNSLEY approached the Berry Event Center and then entered the building with his bicycle. The undersigned noticed several unattended bicycles leaning up against the Berry Event Center, near the same entrance AYNSLEY went in

The undersigned patrolled over that direction and up next to the west entrance of the Berry Event Center, near the link to the PEIF.

All of the bicycles leaning against the BEC were unlocked. One bicycle, an orange LaJolla street cruiser, was observed to be missing a seat, and the front tire was partially blocking the building entrance/exit (door on the right). To the left of the entrance was

a mountain bicycle matching the description of the bike MALEPORT reported stolen. Observed was a Trek, Navigator 200, maroon in color, mountain bike. The bike displayed a 3 speed selector on the left handlebar grip and an 8 speed selector on the right handlebar grip, just as MALEPORT described. The Trek is a 14.5 inch, female type, frame.

The undersigned attempted to contact MALEPORT to see if she could come over and positively identify the bicycle, however the undersigned was unable to contact her on her cellular telephone. The undersigned made contact with MALEPORT's mother, at the alternate telephone number listed in Banner. MALEPORT's mother provided much the same description as earlier received and was elated that the undersigned had located her family's stolen bicycle.

The undersigned radioed for another officer or the MAPS employee come to the undersigned's location to keep a visual observation on the six bicycles outside the Berry Center, while the undersigned went in to the building. The undersigned activated the video camera in patrol unit 6234 to capture the bicycles outside the N.W. entrance to the Berry. Lt. PETERMAN and MAPS employee, GiLL, arrived on scene a short time later to assist. The undersigned also requested dispatch check a bike registration sticker on one of five remaining bikes propped against the BEC. The registration tag #86764 came back registered to GROHMAN, on a blue & gray/purple, Roadmaster, Mt Sport SX mountain bike. The handlebars were observed to be turned upside down and tightened. The undersigned later made telephone contact with GROHMAN.

According to GROHMAN, she is no longer a student at NMU and is residing with her parents in lower Michigan. GROHMAN stated that her mountain bike was stolen last fall (2010) around this time from the Payne/Halverson Courtyard bike rack, GROHMAN said she doesn't believe she ever filed a police report, because she figured she would never get her bike back again, anyway. GROHMAN stated at the time of the larceny, she had her bicycle locked with a combination type lock, and assumed the suspect either cut her lock or figured out her combination. GROHMAN stated she would consider pursuing criminal charges in this matter, because it's not right. GROHMAN added that her bicycle is approximately 10 years old and values it at approximately \$50.00 now. GROHMAN added that she doesn't get back to the U.P., however does have friends who are still students here that may be able to take custody of her bicycle and transport it to her.

GILL remained outside and maintained a visual observation on the bikes, in the event someone would return and attempt to leave with one. Meanwhile, the undersigned and Lt. PETERMAN entered the Berry Event Center. On the ramp, leading down to the ice level, the Roadmaster mountain bike the undersigned observed AYNSLEY riding, was discovered unattended and leaning against the inside rail/wall. The bicycle was unlocked. The undersigned and PETERMAN continued down the ramp and discovered several additional bicycles on both sides of the hall leading into the hockey lockerroom. The undersigned observed several bicycles that had been altered/modified by spray painting. Another fairly new, Columbia brand, Trailhead, Mountain Bike, tan in color, had an NMU bike registration sticker, B7942. The undersigned requested dispatch look up the owners information on tag #B7942 and learned it is registered to GESIOR. The undersigned contacted GESIOR on the cell phone number listed for her in Banner.

According to GESIOR, she is currently on a team bus riding to Minnesota. GESIOR stated she did not lend her bicycle out to anyone and nobody has permission to be using her bike. According to GESIOR, she locked her Columbia Mountain Bike to the Payne/Halverson Courtyard bike rack at approximately 2130 hours, on 09/22/11, upon returning from her class. GESIOR explained she has a cable type lock, with a 4 dial combination. GESIOR stated that her lock was working fine and undamaged when she parked/secured her bike last evening (see attached photos of GESIOR's bicycle and damaged lock).

While the undersigned was on the phone with GESIOR, Lt. PETERMAN was engaged in a conversation with AYNSLEY, who had exited the lockerroom. The undersigned heard Lt. PETERMAN's conversation with AYNSLEY, regarding the "spray painted" bikes.

AYNSLEY stated "they paint the bikes". Lt. PETERMAN asked AYNSLEY who "they" are and AYNSLEY replied NMU hockey players. AYNSLEY was asked who, specifically, on the hockey team paints bicycles. AYNSLEY claimed he didn't wish to say, but knows they paint bikes.

The undersigned and Lt PETERMAN, in an effort to determine the suspects involved and who had possession of what bike outside the lockerroom/building, decided to request the respective riders of the bikes, come out and move them. The undersigned sat AYNSLEY down by himself in the weight room. AYNSLEY asked if he could go back to the lockerroom and the undersigned requested he sit where he was and wait until officers have a chance to get the situation straightened out. The undersigned also requested AYNSLEY stop "texting".

Lt. PETERMAN waited by the bicycles parked on both sides of the hallway outside the hockey weight room/lockerroom, while the undersigned walked through. The nockey team could still be heard on the ice. The undersigned walked through to the home bench and motioned for Assistant Coach John KYLE. The undersigned made contact with John KYLE, since head coach, Walter KYLE, was providing instruction on the ice. John KYLE stated the team has approximately 5 minutes left in practice. The undersigned advised John KYLE that several bicycles are cluttering the hallway directly outside the hockey lockerroom on the west side, near

the weight room. The undersigned also informed John KYLE about the bicycles parked outside the building, believed to be his players, which are blocking the entrance/exitway. John KYLE was informed of the State fire code and the fact that bicycles should not be in the building. The undersigned requested John KYLE advise each player who rode a bike to the rink, to come out and move their respective bicycle, once practice was finished. John KYLE agreed.

The undersigned and Lt. PETERMAN waited near the bicycles for some time. Finally, two lone hockey players came out of the lockerroom, still partially suited up. FLOREK and MACAULAY identified themselves as "team captains" and asked if they could help the undersigned and Lt. PETERMAN. The undersigned made the same request to FLOREK and MACAULAY, as she did to Assistant Coach, John KYLE. FLOREK informed the undersigned the players who rode the bikes there, were not going to come out (of the lockerroom). FLOREK and MACAULAY stated that if all the bikes needed to be moved, they would move them. The undersigned asked FLOREK and MACAULAY which bike they, respectively, rode there today. FLOREK and MACAULAY claimed they hadn't ridden any of the bicycles to the BEC today. Subject, later identified as BAKER, also came out into the hallway. BAKER initially denied being in possession of any of the bicycles and just stood by. The undersigned advised FLOREK and MACAULAY that she did not want them touching the bikes, in that case. According to FLOREK and MACAULAY, it has been a common practice for years, that learn members interchange and use each others bikes, as part of a "bike share program" MACAULAY picked up the white spray painted bike and stated, if you want it moved, then I'll just say I rode it here. The undersigned instructed MACAULAY to leave the bike where it was at. The undersigned requested MACAULAY and FLOREK go back in and send Coach Walt KYLE out to speak to officers.

Walt KYLE exited the hockey lockerroom a short time later and asked the undersigned to explain what this was all about. The undersigned pointed to all the bicycles lining both sides of the hallway. The undersigned informed Walt KYLE that bikes aren't allowed inside the buildings and cannot be cluttering the hallways, per the State fire code. The undersigned further explained to Walt KYLE that it appears some of the bicycles are stolen. Walt KYLE asked the undersigned why she was upset with him and sarrastically asked if the undersigned thought he stole the bicycles. MACAULAY chuckled. Walt KYLE claimed that he didn't even know the bicycles were parked in the hallway. The undersigned advised Walt KYLE she did not believe that he stole any of the bicycles there, however also does not believe that he had absolutely no idea of his team's seemingly traditional "bike share" program. The undersigned further stated that if appears as if his "team captains" were sent out as a "smoke screen" or diversion tactic. It should be noted that Walter KYLE did apologize to the undersigned on 09/24/11, when he stopped at this department to obtain further information regarding this investigation.

Since the players that brought the bikes to the Berry Event Center weren't going to come out of the lockerroom. Lt. PETERMAN wheeled a couple of the bikes in. First, Lt. PETERMAN pushed the tan colored Columbia Trailhead Mountain Bike, belonging to GESIOR, in and asked the team who rode the bike to the Berry today. BAKER stepped forward and admitted he had possession of the mountain bike and rode it to the Berry Events Center/parked it outside the hockey lockerroom. Next, Lt. PETERMAN went outside and retrieved the maroon colored, Trek Navigator 200, Mountain Bike, belonging to MALEPORT. Lt. PETERMAN asked the entire team who rode this bicycle to the Berry today. WALKER stepped forward and admitted he had possession of the stolen mountain bike and rode it to the Berry Events Center.

JONES later exited the lockerroom and stated the gold spray painted mountain bike belongs to him. JONES claimed he purchased the gold painted mountain bike from a former NMU Hockey player, Ray KAUNISTO. JONES initially stated he purchased the bike for approximately \$20.00 and then he later stated it was maybe purchased for a case of beer.

WALCHUK exited the lockerroom and stated he had possession of the white spray painted mountain bike and rode it to the Berry Events Center today. The undersigned observed two additional mountain bikes parked just inside the secure lockerroom entrance. One, just inside the athletic training room, belonged to Kris ROWE, athletic trainer. ROWE stated that is the first day she has ever brought her bike to work. Another, in the hallway, just inside the lockerroom entrance displayed NMU bike registration decal B7981. The black Schwinn is currently registered to Keenan KELLY, also a NMU hockey team member. Neither ROWE's bicycle, nor KELLY's bicycle were confiscated.

Only four suspects, excluding AYNSLEY, stepped forward to admit involvement with the bicycles in question. A total of 13 bicycles were confiscated, with 3 being reported as stolen at this time.

LOCATED INSIDE THE BERRY EVENT CENTER:

The Roadmaster mountain bike that AYNSLEY left on the ramp, evidence tag #140-11E; a white colored Huffy, White River, mountain bike with hot pink & white brake cables, ladies frame, was located near the glass behind the west goalle net, evidence tag #147-11E; Outside hockey lockerroom: GESIOR's tan Columbia, Trailhead, evidence tag #141-11E; a powder blue & gray, Next, Power Climber, 18 speed, with damage to the left brake handle, evidence tag #146-11E; a Outpost Trail, G.T., mountain bike.

"spray painted" white, evidence tag #150-11E; a Diamond Back mountain bike, ladies frame, "spray painted" gold, evidence tag #148-11E; an unknown make/model mountain bike, #98448137 on the inside left front fork, ladies frame, "spray painted" yellow (fresh paint smell), 149-11E.

LOCATED OUTSIDE THE N.W. ENTRANCE OF THE BERRY EVENT CENTER:

GROHMAN's blue & gray Roadmaster, Mt Sport SX, mountain bike, evidence tag #139-11E; MALEPORT's maroon Trek, Navigator 200, 14.5 in mountain bike, evidence tag #138-11E; a gray Diamond Back, Wildwood, mountain bike, evidence tag #145-11E; a red Schwinn, Frontier, mountain bike, evidence tag #144-11E; a blue Next, Ultra Shock, mountain bike, evidence tag #143-11E; and an orange, Next, LaJolla street cruiser bicycle, evidence tag #142-11E.

The undersigned transported BAKER and WALKER to this department for a formal interview (see supplemental information). All of the confiscated bicycles were entered into evidence, photographed, and tagged.

INTERVIEW WITH WALKER:

At approximately 1628 hours, on 09/23/11, the undersigned advised WALKER of the nature of this investigation and of his rights pursuant to Miranda. WALKER requested to place a phone call home and the undersigned agreed. WALKER was allegedly unable to make contact with his father, but was overheard speaking to his sister stating "the rest weaseled their way out of it."

Upon completing his telephone call, WALKER decided to waive his rights, signed the attached waiver form, and provided the following statement.

According to WALKER, at approximately 1310 hours, on 09/23/11, he finished eating lunch at the Marketplace Dining Facility. WALKER stated he was with BAKER and VANDERCOOK. JONES arrived late for lunch and walked in as WALKER and the others were walking out of the Marketplace. WALKER stated he had to get over to the Berry Event Center for a team practice at 1400 hours, 09/23/11, and a meeting prior to practice. Upon leaving the Marketplace, WALKER was allegedly the only one without a bicycle to ride. WALKER stated JONES has the gold "spray painted" mountain bike, VANDERCOOK was riding the yellow "spray painted" mountain bike, BAKER was on the other tan (Columbia) mountain bike.

WALKER stated he observed the maroon color. Trek, mountain bike near the stainwell exit to the Marketplace. WALKER claims the bike was laying on it's side in the grass and not locked up. WALKER admitted that he took the bicycle without permission from the owner because everyone else had a bike to ride and he wasn't going to walk to the ice rink all by himself. WALKER added that he knows of quite a few guys taking bikes, so he did not think much of it.

WALKER said BAKER, came from the Payne/Halverson Courtyard area, riding the other tan (Columbia) bike and VANDERCOOK's bike was on the same side of the building as WALKER. WALKER and VANDERCOOK allegedly met up with BAKER on the sidewalk near Payne Hall and the group continued eastbound on Center Street, toward the Berry Event Center. WALKER could not remember JONES biking with the group, as he was running late. WALKER explained that he crossed over Presque Isle Avenue and rode through gate/chain link fence where Center Street dead ends, just west of the Superior Dome. WALKER then continued to ride the stolen Trek bicycle to the Berry Event Center.

According to WALKER, VANDERCOOK has a car and he sometimes will catch a ride with VANDERCOOK to the rink. WALKER said VANDERCOOK's car is parked a long way away, so it's just as fast biking to the rink. The undersigned asked WALKER if he has ever taken a bike in the past that does not belong to him. WALKER explained that he used to have an old bike that he obtained from the "bockey house". WALKER said the bike was yellow, spray painted yellow, however claimed it wasn't the same bicycle that the undersigned confiscated today. WALKER stated that he rode it to the rink one day and someone took it from him. WALKER claimed he hasn't seen the bike around since that time. WALKER called himself "bikeless", now, and that is why he took the maroon colored Trek (MALEPORT's) bike.

WALKER believed someone from the Berry Event Center (hockey teammates) must have taken his bike. WALKER stated "it just seems like everyone does it, so didn't think of it in the context of stealing."

The undersigned asked WALKER in addition to himself. VANDERCOOK, BAKER, and JONES, if he saw any other teammates riding bicycles to the Berry today? WALKER stated WALCHUK had the white, spray painted, bicycle and that it was mostly the freshman who rode the bikes. According to WALKER, everyone ends up finding bikes on "party night" at the hockey houses. The undersigned asked WALKER if this is where the bikes get repainted (at the hockey houses). WALKER denied it and said that he and VANDERCOOK allegedly painted the bikes in the freshman parking lot on Center Street. WALKER admitted that he spray

painted his bike yellow, at the same time VANDERCOOK spray painted his bike yellow

The undersigned asked WALKER who he obtained his yellow bicycle from and he claimed "from one of the guys at one of the houses". WALKER stated he's had the bike forever. The undersigned asked WALKER when he arrived Marquette and he stated the end of August 2011, approximately a month ago. WALKER did not have "his bicycle" prior to arriving in Marquette. WALKER claimed he obtained "his bicycle" from one of the hockey houses after a party. WALKER said he was leaving and just took it from the back yard of the "hockey house" on either Fitch Street or Michigan. WALKER stated he's pretty sure it belongs to one of the guys on his team. WALKER again claimed that it is not the same yellow spray painted bike the undersigned confiscated and does not know where it may be now. WALKER stated it may be at one of the hockey houses.

The undersigned asked WALKER if he would be willing to submit to a polygraph examination if one were arranged. WALKER stated "yes". The undersigned requested WALKER complete a written statement and he compiled (see attached).

As the undersigned concluded the interview with WALKER, she released him and advised him he was free to go. As the undersigned was holding the looby door open for BAKER to enter, the undersigned observed WALKER remove a ball point pen from the cup holder on the table in this department's lobby. The pens are placed there, next to the parking forms, for patrons to use. WALKER began walking out the door with the pen he obtained. When the undersigned observed this, she asked WALKER where he was going with the pen. WALKER stated "I need pens, I'm low on them." The undersigned asked WALKER if he had completely forgotten about the conversation he had just had with the undersigned and asked where he gets his sense of entitlement from. The undersigned instructed WALKER to put the pen back and move along. WALKER complied

INTERVIEW WITH BAKER:

At approximately 1730 hours, on 09/23/11, the undersigned advised BAKER of the nature of this investigation and of his rights pursuant to Miranda. BAKER decided to waive his rights, signed the attached waiver form, and provided the following statement. According to BAKER, he left Payne Hall for the Berry Event Center at approximately 1000 hours, on 09/23/11. BAKER admitted he rode a small blue bicycle, "the one with the busted handlebars", that he took off the Payne/Halverson Countyard bike rack. The undersigned believes this bicycle to be GROHMAN's bike, as it is a small frame, Roadmaster, blue & gray in color, with the handlebars turned and tightened upside down.

According to BAKER, the tan/gold Columbia mountain bike (GESIOR's) was already at the rink when he arrived, as he observed it parked there. BAKER estimated he worked out for approximately 1/2 hour - 45 minutes and then grabbed the tan bike (GESIOR's) and rode it back to the dorms. BAKER stated after returning to his residence, he took a nap and then went to eat lunch at the Marketplace Dining Facility, at approximately 1240 hours. After lunch, BAKER stated he removed the tan Columbia mountain bike (GESIOR's) from the Payne/Halverson bike rack, where he had parked it prior to lunch, and rode it back to the Berry Event Center for practice!

On the way to the Berry Event Center after lunch, BAKER said he rode the tan Columbia mountain bike (GESIOR's). WALKER rode the maroon colored Trek, WALCHUK rode the white "spray painted" bike, and VANDERCOOK was also riding a bicycle, however BAKER could not recall which one. JONES apparently rode the gold "spray painted" bike back to the Berry, but was a short distance behind the rest of the group, as he was running late.

BAKER denied breaking the combination lock on GESIOR's Columbia mountain bike and stated it was already broken when he got on it. BAKER stated he hasn't taken a bicycle off the Payne/Halverson bike rack that he hasn't seen before at the rink. BAKER explained that the guys (NMU Hockey Team) just ride them and share/interchange bikes with each other. The undersigned advised BAKER there would be no problem with that program, as long as the bicycles were theirs to begin with. BAKER stated he allegedly knows who broke the lock off GESIOR's bike.

BAKER asked the undersigned if JONES didn't exit the lockerroom and admit he broke the lock off the tan Columbia (GESIOR's) bike, prior to using it this morning. The undersigned advised BAKER that JONES did not say any such thing when he exited the lockerroom. JONES came out of the lockerroom and admitted riding the gold "spray painted" bicycle to the Berry Event Center this afternoon, however claimed he is the owner of the bike. According to BAKER, JONES admitted to him and other fear members inside the hockey lockerroom that it was he, who damaged/removed the lock on the Columbia mountain bike on the morning of 199/23/11.

The undersigned asked BAKER if he heard JONES say this directly to him or if he heard it from another teammate. BAKER verified that JONES said this directly to him and alleged that he was going to go out into the hallway and inform officers of such. JONES

failed to do so. BAKER also didn't view his actions as "stealing", but rather using or borrowing bikes amongst teammates as part of their bike share program. The undersigned asked BAKER if he would be willing to submit to a polygraph examination if one were to be arranged. BAKER stated "yes".

The undersigned requested BAKER complete a written statement and he complied (see attached).

INTERVIEW WITH AYNSLEY:

At approximately 1037 hours, on 09/24/11, the undersigned advised AYNSLEY of the nature of this investigation and of his rights pursuant to Miranda. According to AYNSLEY, he has been using/riding a different blke for the past month now. AYNSLEY stated he arrived Marquette around the end of August 2011 and started attending NMU. AYNSLEY said he has no idea who owns the bicycle, however believed it must belong to one of the guys on the hockey team.

According to AYNSLEY, 09/23/11 was the first day he used/rode the silver/blue Roadmaster, Mt Fury, mountain bike that the undersigned observed him on. AYNSLEY explained how the veteran players on NMU Hockey Team's have seniority over the "bike share program" and can take/use someone else's bicycle whenever they want. AYNSLEY added that bikes get taken all the time. AYNSLEY said he was informed by the "upperclassmen" not to be upset if you come out of the lockerroom and find your bike is gone. AYNSLEY explained that if the upperclassmen need a bike, they just take it and everyone sort of knows that is the rule.

The undersigned asked AYNSLEY if he has ever taken a bike from the Payne/Halverson bike rack and he stated "no". According to AYNSLEY, he left the Berry Event Center on 09/23/11, at approximately 1330 hours, to run a book back to his tutor at the dorms. AYNSLEY said he then rode the same bike back to the Berry Event Center and that's when he was stopped by the undersigned. AYNSLEY again stated he believed the bike belonged to one of the guys on the team, but wasn't certain who owned it. AYNSLEY stated all the bikes around the rink (BEC) seemed to just be "community bikes" within the team.

AYNSLEY advised the undersigned that BAKER did not damage/remove the lock on the tan Columbia mountain bike. AYNSLEY stated he heard JONES say that he did it According to AYNSLEY, JONES normally rides the gold "spray painted" mountain bike and told him that he purchased the bike from some other guy on the nockey team. AYNSLEY stated he has used/ride the gold "spray painted" bike in the past, too.

The undersigned asked AYNSLEY if he would be willing to submit to a polygraph examination if one were to be arranged.

AYNSLEY stated "yes". The undersigned requested AYNSLEY complete a written statement and he complied (see attached).

FOLLOW UP WITH VICTIM, MALEPORT:

At approximately 1350 hours, on 09/24/11, MALEPORT entered this department to provide a written statement regarding this incident (see attached). According to MALEPORT, she does not wish to pursue criminal charges against the person responsible for stealing her property. MALEPORT stated when she learned that her bicycle was located over at the Berry Event Center, she assumed it was probably one of the hockey players. MALEPORT claims she has attended parties at the "hockey house" in the past and her roommate is allegedly dating one of the hockey players, Kory KAUNISTO, who is also from her home town of Sault Ste Marie. MI.

MALEPORT stated that KAUNISTO came over to her room on the evening of 09/23/11, along with another teammate. NUGENT, who informed her that WALKER is really a good guy and that he may get kicked off the hockey team if he is charged with stealing ner bike. KAUNISTO and NUGENT further explained to MALEPORT that everyone on the hockey team "borrows" bikes. The undersigned asked MALEPORT if KAUNISTO and NUGENT pressured her into making her decision to pursue charges or not. MALEPORT claimed not.

The undersigned asked MALEPORT if the yellow spray painted dot of paint had been on her right rear fork of her maroon Trek mountain bike prior to this incident and she claimed it had been.

The undersigned obtained a photograph of MALEPORT with her bicycle, after she positively identified it as her property. At approximately 1332 hours, on 09/27/11, the undersigned released MALEPORT's bicycle to her. MALEPORT signed the back of property record receipt, evidence tag #138-11E, as well as the evidence book.

INTERVIEW WITH JONES:

At approximately 1636 hours, on 09/24/11, the undersigned advised JONES of the nature of this investigation and of his rights pursuant to Miranda. JONES decided to waive his rights, signed the attached waiver form, and provided the following statement. According to JONES, he saw the tan Columbia, Trailhead, mountain bike (belonging to GESIOR) for the first time, at the rink, on 09/23/11. JONES claimed he had never seen the Columbia mountain bike anywhere prior to officers questioning the team about who rode it. JONES denied seeing the Columbia bike anywhere else on campus or at the Payne/Haiverson Courtyard bicycle rack.

JONES stated he has his own bike to ride, the gold "spray painted" mountain bike. According to JONES, he normally parks his gold bicycle on the east side of the Berry Event Center, near the zamboni entrance. JONES said he has had the gold spray painted mountain bike since "day one". JONES said he arrived in Marquette on approximately 08/23/11 and he obtained the bike within a couple of days. JONES said he has a lock for his bike and locks it to the bike rack outside Payne Hall.

The undersigned asked JONES who he got his gold spray painted bike from? According to JONES, one of the first days after he arrived Marquette/NMU, he was with a group of guys skating at the Berry Event Center and he observed the gold spray painted bike at the Berry. JONES stated he was hanging out with the hockey guys and then he went over to one of the hockey houses, although he can't remember where the house is located or who lives there. JONES stated he was in the backyard of the hockey house at a "fairly large get together", meeting people. JONES said he was talking with other hockey players about who has cars and how they were going to get around. JONES claimed some guy offered the bike to him and he willingly volunteered to give the subject something for it. JONES believed he gave the subject \$25.00 cash.

JONES claims he doesn't know the former players name, but the bike was passed on to him by one of the guys who were taking off/leaving town. JONES was allegedly told by the subject that he had no need for the bicycle any longer. JONES did purchase a lock for the bike, however. The undersigned reminded JONES that on 09/23/11 he provided the name of "Ray KAUNISTO" as the person he purchased the bike from. JONES now stated he doesn't think it was Ray KAUNISTO, as he asked his younger brother, Kory KAUNISTO and he allegedly said his brother didn't have a bike that was spray painted gold.

JONES alleged that the only bike he rode was the gold "spray painted" bike to and from the Berry Event Center on 09/23/11.

JONES denied ever touching or riding the tan Columbia mountain bike. JONES also denied damaging/removing the combination lock from GESIOR's bicycle and claimed that bike is unfamiliar to him. JONES stated he has no idea why his teammates would say that he damaged the lock on the Columbia bicycle, because he has his own bike to ride. JONES claims the bike was already spray painted gold when he obtained it.

The undersigned asked JONES if he would be willing to submit to a polygraph examination if one were arranged and he stated "yes". The undersigned requested JONES complete a written statement and he complied (see attached).

FOLLOW UP WITH VICTIM, GESIOR:

At approximately 1022 hours, on 09/27/11, GESIOR entered this department to recover her bicycle. Investigator LADUKE advised the undersigned that once GESIOR positively identifies the bicycle as hers, the undersigned can obtain a photograph of GESIOR with the bike and then release it to her (per The Marquette County Prosecutor's Office).

According to GESIOR, after returning from her class on 09/22/11, approximately 2130 hours, she parked her Columbia. Trailhead, mountain bike on the Payne/Halverson courtyard bike rack and locked it. GESIOR stated her Master (dial combination) Lock was working fine at that time. GESIOR observed what remained of her damaged lock, still hanging on her handlebars. GESIOR valued her damaged property at approximately \$25.00.

GESIOR stated that she has never lent her bicycle out in the past and gave no one permission to use her bicycle, while she was out of town with the NMU Cross Country Team. GESIOR added that she is happy to get her bicycle back, because she doesn't have a car and it is her only mode of transportation. GESIOR observed no additional damage to her Columbia mountain bike, itself, only to her lock.

GESIOR said she is fine with pursuing criminal charges against the suspect(s) involved, if the Marquette County Prosecutor's Office so chooses. GESIOR valued her Columbia mountain bike, with added kickstand, bottle holder, and Master Lock at approximately \$225.00. The undersigned requested GESIOR complete a written statement and she complied (see attached).

At approximately 1043 hours, on 09/27/11, the undersigned released GESIOR's bicycle to her. GESIOR signed the back of the

property record receipt, evidence tag #141-11E, as well as the evidence book.

INTERVIEW WITH VANDERCOOK:

At approximately 1315 hours, on 09/28/11, the undersigned advised VANDERCOOK of the nature of this investigation and of his rights pursuant to Miranda. VANDERCOOK decided to waive his rights, signed the attached waiver form, and provided the following statement.

According to VANDERCOOK, he has a car that he normally drives to the rink (BEC). VANDERCOOK stated some of his teammates have bicycles that have been left at the Berry Event Center, that they use to get back and forth. VANDERCOOK said many of the guys had bikes prior to him getting here (NMU). VANDERCOOK stated that he used the yellow (spray painted) bike on 09/23/11 to get over to the Berry Event Center, since he didn't have his car keys on him. VANDERCOOK added that his car is parked a long distance away from his dorm, anyway, so he rode the bike.

The undersigned asked VANDERCOOK where he obtained the yellow spray painted bike? VANDERCOOK explained that the first weekend he was in Marquette, he attended a "social gathering" at a house "off campus". VANDERCOOK said with certainty that it wasn't a "hockey house". VANDERCOOK claimed the house was located somewhere in the area of 3rd Street and possibly Hewitt. According to VANDERCOOK, someone (unknown) told him to "go ahead and use one of those bikes", which VANDERCOOK said were leaning along side of the house. VANDERCOOK stated there were a handful of bikes there and he selected one. VANDERCOOK stated that he had "a couple" drinks (alcohol) and didn't want to risk driving his car home. VANDERCOOK added that it was too far to walk back to the dorms.

After riding the mountain bike back to Payne Hall, VANDERCOOK allegedly parked it at the Payne/Halverson courtyard bike rack.

VANDERCOOK stated he never locked the bike up and it just remained there. The undersigned asked VANDERCOOK what color the bike had originally been. VANDERCOOK daims the bicycle was yellow when he received it. The undersigned asked VANDERCOOK if he spray painted it yellow after receiving it. VANDERCOOK replied "no mam"

The undersigned asked VANDERCOOK if he recalls spray painting his bike, along with WALKER, in the Center Street parking lot (Lot #21). VANDERCOOK admitted to being there with WALKER, while WALKER spray painted his bicycle, however denied he spray painted his bike. The undersigned asked VANDERCOOK if WALKER spray painted two bicycles. VANDERCOOK claimed he didn't have "his bike" there that day, as he drove his car over. The undersigned advised VANDERCOOK that the yellow spray painted bike that he had in his possession, is now in the undersigned's property room. The undersigned further advised VANDERCOOK, that the undersigned took notice of the fresh paint odor coming from the bike while processing it.

VANDERCOOK informed the undersigned that he and some of his teammates, who live in Payne Hall, will sometimes ride their bikes from Payne Hall to the area of the Summit Street Apartments and then jump in his car, parked in Lot #21. VANDERCOOK stated they will leave the bikes near the apartments. The undersigned informed VANDERCOOK that WALKER provided a statement, indicating that he spray painted the bicycle yellow, along with WALKER.

VANDERCOOK claimed that the only day he used the "spray painted" yellow bicycle, in addition to the night he obtained it from the party, was on 09/23/11. According to VANDERCOOK, he drove his car to the Berry Event Center in the morning for work out and then rode the yellow bike in the afternoon to go back for practice. VANDERCOOK stated he rode with WALKER, BAKER, WALCHUK, and JONES. The group allegedly rode eastbound on Center Street, all the way to the Dome and then through the parking lot to the Berry Event Center. VANDERCOOK claims that all other times, he either drove his car or walked to practice.

The undersigned asked VANDERCOOK why he failed to come out into the hallway and move his bicycle on the afternoon of ... 09/23/11, since he had rode it to the BEC that day? VANDERCOOK said he never heard the coaching staff ask those that rode bikes to go move them. VANDERCOOK claimed that he went into the athletic trainers room, however, after exiting the ice.

VANDERCOOK stated he does not know who owns the bicycle he was in possession of or how long it has been "passed around" campus. The undersigned requested VANDERCOOK complete a written statement and he complied (see attached).

It should be noted that this yellow spray painted mountain bicycle is so thickly painted that the undersigned and other officers from this department are unable to determine the make and model of the bike. It is quite possible that the bicycle may be one reported as stolen, but it has been attered beyond the point of recognition.

FOLLOW UP WITH VICTIM, CHEYENNE WALKER:

On 09/28/11 Officer RICE used a paint remover on the NMU registration decai that was affixed to the G.T., Outpost Trail, mountain bike. This bicycle had been spray painted with white paint. The registration decal revealed #B7618. The undersigned requested dispatch look up and print the information pertaining to that registration. The registered owner of the bicycle was determined to be Chevenne WALKER.

At approximately 1415 hours, on 09/28/11, the undersigned made telephone contact with Cheyenne WALKER. According to Chevenne WALKER, she had her bicycle stolen around the end of the first week of classes (fall 2011). Chevenne WALKER advised she had her bike locked to the bicycle rack outside Hunt Hall. Cheyenne WALKER provided a description of her bicycle. matching the one registered with this department and now in the undersigned's possession. Cheyenne WALKER was disappointed to learn that her bike is now spray painted white.

The undersigned met with Cheyenne WALKER on 09/28/11, at approximately 1112 hours, and obtained further information. Cheyenne WALKER stated she had her G.T. mountain bike secured to, either, the Hunt Hall bike rack facing Lot #9 or the covered Hunt Hall bike rack, facing Lot #16. Cheyenne WALKER said she would routinely use either of those bike racks when she still had her bicycle. Cheyenne WALKER stated with certainty that she had her bike locked. Cheyenne WALKER showed the undersigned the key, still on her key chain, with the letter "K" on it.

According to Cheyenne WALKER, she did contact this department to report her bike stolen immediately after noticing it gone. Cheyenne WALKER explained that an officer did contact her back to take the report, however she was in a half government meeting and couldn't take his call. Cheyenne WALKER stated she never called back. After a week of looking for her bike, Cheyenne WALKER figured she would never be getting her bike back.

Cheyenne WALKER stated she checked with her father and he valued her G.T., Outpost, mountain bike at approximately \$300.00. Cheyenne WALKER stated that her bike was equipped with handlebar extenders, a bottle holder, and a black bag underneath the seat, which she used for storing her lock when riding the bike. The undersigned informed Cheyenne WALKER that the black bag is no longer attached to her bicycle. Cheyenne WALKER valued the black bag at approximately \$10.00 and her missing lock at approximately \$20.00.

The undersigned requested Cheyenne WALKER complete a written statement and she complied (see attached). Cheyenne WALKER advised the undersigned that she wishes to pursue criminal charges in relation to this crime.

FOLLOW UP WITH VICTIM, POSPYCHALA:

On 09/28/11 a report was located in this department's (2011) file of stolen bicycles matching the description of the now gold spray painted, Diamond Back mountain bike. The serial numbers also matched up. The report was originally taken by Officer WERNHOLM on 08/27/11 (see complaint #2224-11). The registered owner of the Diamond Back mountain bike is POSPYCHALA.

On 09/29/11, the undersigned made contact with POSPYCHALA. POSPYCHALA reported that she had her bike locked to the Magers Hall bike rack (facing Lot #11), on the south side of the building. POSPYCHALA described her bike lock as a 4 digit, dial type, combination lock. According to POSPYCHALA, she found her lock laying on the ground, near the bike rack, shortly before filing the report. POSPYCHALA stated her lock was damaged, like it had been pulled apart POSPYCHALA said she just threw the lock away. POSPYCHALA valued the combination lock at approximately \$10.00.

POSPYCHALA valued her blue Diamond Back mountain bike, now spray painted gold, at approximately \$300.00. POSPYCHALA added that she doesn't have a car at NMU and her bike is her main source of transportation. POSPYCHALA said the past few weeks without her bicycle have really "sucked", because she has had to borrow other students bicycles to get to her classes across campus. POSPYCHALA advised the undersigned she wishes to pursue criminal charges in relation to this crime.

The undersigned requested POSPYCHALA complete a written statement and she complied (see attached).

INTERVIEW WITH WALCHUK:

At approximately 1732 hours, on 09/27/11, the undersigned advised WALCHUK of the nature of this investigation and of his rights pursuant to Miranda. WALCHUK decided to waive his rights, signed the attached waiver form, and provided the following

statement. According to WALCHUK, he has no idea who the owner of the white "spray painted" bike is and he has never ridden the bike prior to the afternoon of 09/23/11. WALCHUK stated the bike has been at one of his teammates house for some time now WALCHUK is a freshman at NMU and stated he just arrived Marquette/NMU approximately one month ago.

The undersigned asked WALCHUK whose house the bicycle had been at? WALCHUK stated everytime he has gone to the "hockey house" on Fitch Avenue, which is almost daily, he has seen the white bicycle leaning against the side of the house. WALCHUK claimed he has not observed the white spray painted bike at the Berry Events Center in the past.

According to WALCHUK, at approximately 12 noon, on 09/23/11, a resident of the Fitch "hockey flouse" a Stephan VIGIER, allegedly rode the bicycle to NMU's Campus and parked the bicycle on the bike rack on the south side of the Payne/Halverson Lobby, near the Marketplace exit. WALCHUK stated he received a text message from VIGIER advising WALCHUK that he left the bike on the bike rack, unlocked, and instructed WALCHUK to go ahead and use the bike if he needed it. WALCHUK admitted riding the white spray painted bicycle to the Berry Event Center on the afternoon of 09/23/11.

WALCHUK added that VIGIER then caught a ride to the Berry Event Center in another teammate's car. The undersigned clarified with WALCHUK that VIGIER, who lives on Fitch Street, allegedly doubled back to come to campus, drop the white bicycle off, and then caught a ride to the Berry Event Center? WALCHUK stated that is correct. The undersigned asked WALCHUK if he saw VIGIER at lunch in the Marketplace and he stated "no". The undersigned asked WALCHUK if he has the alleged text message from VIGIER saved? WALCHUK stated he did not save it.

According to WALCHUK, he does not own a bicycle of his own. WALCHUK claims he normally catches a ride with a teammate who has a car or walks to the rink. WALCHUK believes that he rode bikes, along with BAKER, to the Berry Event Center after lunch on 09/23/11. WALCHUK said he caught a ride with, either, VANDERCOOK or DOREIGHTY to the rink in the morning. WALCHUK claimed to have no idea who spray painted the bicycle white and added that he doesn't believe anyone on his team would do so. WALCHUK said he has ridden the gold spray painted bicycle in the past. WALCHUK believed JONES bought the gold spray painted bicycle.

WALCHUK added that he believes the white spray painted bicycle was left at the "hockey house" after a party there one night. WALCHUK stated that someone told him the bike was already spray painted white when it arrived there. The undersigned asked WALCHUK who advised him of that? WALCHUK could not recall the name of the person, but alleged it was one of the guys who reside at the Fitch Street house.

The undersigned asked WALCHUK if he would be willing to submit to a polygraph examination if one were arranged and he stated "yes". The undersigned requested WALCHUK complete a written statement and he complied (see attached).

At approximately 1345 hours, on 10/03/11, the undersigned determined the yellow spray painted bicycle, in which VANDERCOOK admitted being in possession of, to actually be a Huffy, Ironman, mountain bike. The undersigned rubbed some of the yellow spray paint off the frame, with the help of some paint thinner. One report within the (2010) stolen bicycle file matched this description (see complaint #1233-10).

On 10/03/11 the undersigned contacted the complainant on report #1233-10, SKROBECK. The undersigned asked SKROBECK if he could come to this department, at his convenience, to possibly identify the bicycle in this department's possession. SKROBECK agreed. It should be noted complaint #1233-10 was filed on 05/07/10, at approximately 1525 hours, with Officer RICE. The report indicates the larceny occurred between 2030 hours, on 04/30/10, and 1205 hours, on 05/01/10, with the (locked) bicycle being stolen from the Payne/Halverson Courtyard bicycle rack.

SKROBECK arrived at this department at approximately 1500 hours, on 10/05/11. The undersigned removed the Huffy, ironman, mountain bike from this department's evidence room for SKROBECK to examine. SKROBECK positively identified the bicycle as his and the one that he reported stolen on 05/07/10. According to SKROBECK, the bicycle had originally belonged to ASNMU and their "bike share program". SKROBECK stated he was a member of ASNMU at the time. SKROBECK said the orange/red colored Huffy, Ironman, mountain bicycle kept breaking and he would be the one to fix it.

The undersigned turned the bicycle upside down, so SKROBECK could observe the original colors on the underside of the frame SKROBECK recognized the bicycle by the unique original colors and several other characteristics of the bicycle (hand grips, gear selector switches, and "fog plate"). SKROBECK explained how he had added the "fog plate" to the rear tire and what it's purpose is.

SKROBECK claimed he is the one who purchased all the locks for the ASNMU bike share program. SKROBECK stated he had this bicycle locked to the Payne/Halverson bicycle rack at the time it was stolen. SKROBECK was apprehensive about pursuing criminal charges against the suspect involved, saying that he is afraid of retaliation. The undersigned explained to SKROBECK that the ultimate decision to charge is the Marquette County Prosecutor's Office.

Narrative text

At approximately 1520 hours, on 10/19/11, the undersigned was looking through the 2011 stolen bike file at this department. The undersigned observed a recent stolen bicycle report (#2550-11) that hadn't been filed the last time the undersigned looked through the filed reports. The report was initially taken by the undersigned on 09/14/11 and allegedly occurred between 0800 - 1230 hours, on 09/14/11. The report caught the undersigned officers attention, because the date and location (TFA) matched the anonymous crime tip received by this department on the afternoon of 09/14/11.

The undersigned reviewed report #2550-11 and discovered the make, model, and serial number matched the bicycle (spray painted yellow), which was initially believed to be SKROBECK's. When the undersigned initially located SKROBECK's stolen bicycle report (#1233-10), the description appeared to be similar to the yellow spray painted bike confiscated and in this department's possession. SKROBECK then came in to this department and mistakenly identified the bike to be his.

The true owner of the orange/red, Huffy, Ironman Mountain Bike, bearing serial #98448137, is DURST. DURST had this bicycle registered with Public Safety at the start of the school year. (See attached bicycle registration) At approximately 1755 hours, on 10/19/11, DURST arrived this department and examined the (yellow spray painted) bicycle tagged as evidence #149-11E. DURST positively identified the once orange/red colored, Huffy, Triathlon Pro Ironman bicycle, bearing serial #98448137, as her property.

DURST said she has been inconvenienced without having her bicycle and borrowing another from a friend. DURST began crying and explained that although her bicycle isn't very expensive, she has had it for 7-8 years and it has sentimental value. DURST believed she paid approximately \$150.00 dollars for her bike, but if she had to replace it now, she believes the same bike would be over \$200.00. DURST said she didn't know if she wanted to pursue criminal charges or not, as she really doesn't have the time to go to court.

SKROBECK was contacted and informed the bicycle he believed was his, actually belongs to DURST.

Also at approximately 1520, on 10/19/11, the undersigned further investigated the Roadmaster. Mt Fury, Mountain Bike that AYNSLEY was observed riding (tagged as evidence #140-11). The undersigned located a stolen bicycle report #3061-10, filed on 11/03/10, with Officer RICE. The bike was described as silver in color, with a single blue stripe. The bike registration decal and the purple bell were now missing on the bicycle. The larceny was reported by BROWER and allegedly occurred between 2030 hours, on 10/28/10 - 1200 hours, on 11/01/10.

The undersigned initially overlooked this bicycle as a match to the one confiscated on 09/23/11, due to the serial number not matching up. Officer RICE had noted in his report the serial number to be #R3517WMBT. It is believed Officer RICE retrieved this information from the registered information provided by the owner (see attached). Upon closer inspection, the undersigned observed a small sticker on the lower frame just above the kick stand, bearing this number as the "model number", not "serial number".

The undersigned attempted contact with BROWER to have her come to this department and possibly identify the bike.

Narrative text

At approximately 1625 hours, on 10/24/11, investigator LADUKE, NMU Public Safety Department, contacted Wait KYLE, head hockey coach of the NMU mens hockey team. LADUKE requested KYLE make contact with VIGIER and ask that he come to this department for an interview regarding this ongoing investigation. KYLE complied.

It should be noted that during the Dean of Students hearing on 10/21/11. VIGIER admitted to the panel that he had been in possession of the "white spray painted" bicycle prior to WALCHUK being in possession of the same bike on 09/23/11. VIGIER stated he obtained the bicycle from his residence of Fitch Street, Marquette, and rode it to NMU Campus. VIGIER allegedly parked the bike on a bike rack, near Payne Hall Lobby/Marketplace, and left it unlocked for WALCHUK to use.

VIGIER maintained that the bike had been left at the above residence after a large party at the beginning of the semester.

It should be noted that C. WALKER had contacted this department at approximately 2045 hours, on 09/07/11, to report her bike as "stolen" (see attached phone message log). The large party at Fitch, in which the Marquette City Police responded and issued a loud noise citation to the renters was on 09/01/11.

At approximately 1740 hours, on 10/24/11, the undersigned met with VIGIER and advised him of the nature of this investigation. The undersigned also advised VIGIER of his rights pursuant to Miranda. VIGIER decided to waive his rights, signed the attached waiver form, and provided the following statement.

According to VIGIER, the "white spray painted" bicycle had been located at his residence on the morning of 09/23/11. VIGIER believed it was sometime during the late morning, on 09/23/11, that he took and rode the bicycle onto campus. VIGIER stated he parked the bike outside the Marketplace and on the bike rack, just south of the Payne Hall Lobby. VIGIER left the bike unlocked on the rack.

The undersigned asked VIGIER if he is the owner of the bike and he stated "no". The undersigned asked VIGIER if he knows who the bicycle belongs to and he stated "no". VIGIER added that he only knows what he heard in the Dean of Students hearing about the victim/owner of the bike. VIGIER also denied knowing the bicycle is stolen. According to VIGIER, he and his housemates had some parties earlier in the school year, one of which was cited by the Marquette City Police for a loud noise violation. VIGIER claimed the bicycle had been left at the house after a party, leaning against the staircase in the backyard. VIGIER stated the bike is still in the same location. According to VIGIER, the white spray painted bike has been at his residence for quite some time.

VIGIER stated no more parties were thrown at his house after receiving the noise violation on 09/01/11. VIGIER said the landlord is a "really old lady" and when they went to pay their rent, she told them "no more parties". The undersigned asked VIGIER why he nadn't called the police to report the property and ask to have it picked up/removed? VIGIER said he assumed the owner would come back to pick it up.

VIGIER said he's seen other painted bikes around. VIGIER claims he couldn't tell this white spray painted bike was stolen.

VIGIER stated he's observed spray painted bikes on the Payne/Halverson Courtyyard bikes racks in the past. The undersigned asked VIGIER if he's ever seen his teammates on spray painted bikes in the past. VIGIER hesitated and stated "I probably have." The undersigned then asked VIGIER who nides the gold spray painted bicycle and he responded "I wouldn't know." The undersigned asked VIGIER who nides the vellow spray painted bicycle. VIGIER claims he knows the bikes the undersigned is referring to, but doesn't know who rides it, specifically."

After eating lunch at the Marketplace on 09/23/11, VIGIER stated he caught a ride back to the Berry Events Center with another teammate who has a vehicle, however he cannot recall who. VIGIER said he remembers "texting" throughout the morning of 09/23/11. According to VIGIER, he knows he told WALCHUK that he could take the white spray painted bike and use it! VIGIER

believes he told WALCHUK this via text message.

VIGIER claimed that 09/23/11 was the only day he used the white spray painted bicycle. VIGIER said he owns a vehicle, so will usually drive to the rink or walk. The undersigned asked VIGIER if he stole the new white spray painted bicycle. VIGIER stated "no". The undersigned asked VIGIER if he would be willing to submit to a polygraph exam if one were arranged and he stated "yes". The undersigned requested VIGIER complete a written statement and he complied (see attached).

VIGIER advised the undersigned that two other bicycles remain in the back yard of his residence and have been there for some time. According to VIGIER, one of the bikes allegedly belongs to a teammate's (GRON) girlfriend. GRON apparently rode the bicycle over to VIGIER's residence on the day of the rain/wind storm and VIGIER gave him a ride (in his car) nome. VIGIER described this bicycle as being blue in color. (See evidence tag #185-11E)

The second bicycle, described as an older bike with fenders & curved handlebars, VIGIER said is baby blue in color. VIGIER claimed the bike belongs to AUK. VIGIER does not believe AUK is residing in Marquette any longer. The Huffy, Cranbrook, cruiser style bike, is actually mint green in color. There is still an old tag hanging on the handlebars of the bike, reminding of registration (see evidence tag #184-11E).

The undersigned followed VIGIER to his residence at the conclusion of this interview and recovered the two aforementioned bicycles. The undersigned provided VIGIER a property record receipt on #184-11E and #185-11E. Subject, identified as MACCAULAY, made contact with the undersigned in the driveway and advised the blue, Diamond Back, mountain bike belongs to GRON's girlfriend, LEGAULT. MACCAULAY telephoned LEGAULT and advised her that officers from this department were taking/securing her bicycle. The undersigned then spoke to LEGAULT and advised her she can contact this department to claim her property.

At approximately 2000 hours, on 10/24/11, the undersigned attempted to confirm ownership of the two recovered bicycles. Neither bicycle was registered with this department. AUK is no longer a student at NMU. The undersigned checked the stolen bicycle files from 2010 & 2011.

On 10/25/11 the undersigned attempted telephone contact with AUK and left her a message regarding her bicycle. At approximately 1430 hours, on 10/25/11, AUK returned the undersigned officer's phone call. AUK stated "I let them have it". According to AUK, upon moving from Marquette, she gave her green Huffy cruiser to "the hockey guys at Fitch." AUK stated she purchased the bike from Walmart and it wasn't very expensive. AUK said if any of the guys who reside there still want the bike, they can have it.
